III. Approval of Minutes:

- **Vote to Approve Regular Meeting Minutes from November 9, 2021:**
 - J. Anderson motioned to approve minutes from the November 9 Regular Meeting as distributed, and C. Gamble seconded. The LSC voted to approve, 9-0.

- **A. Chair**

- **B. CIWP**
 - There are no new updates at this time. A timeline for next year's plan is forthcoming from the district.
- **C. PPLC**
 - The PPLC did not meet in December.
- **D. Principal (See December 14, 2021 Principal Report for more information)**
 - Since the November LSC meeting, 6 classrooms have been in quarantine as a result of 7 positive cases. Challenges related to simultaneous remote instruction for students individually quarantined as close contacts were highlighted.
 - At-home tests are intended to be provided over winter break with results anticipated prior to January 3.
 - C. Gamble also highlighted the following from his report:
 - Attendance is -1.0% from last month (91.7%).
 - The playground renovation Participatory Budget initiative has more than 100 endorsements. Information can be found throughout the Solomon campus.
 - With the help of Lead180, teams will have time on January 11 & 12 to identify priority standards and collaborate.
 - The search continues for a Mandarin teacher, with 5 candidates for the open first grade position.
