- **Vote to Approve Regular Meeting Minutes from January 11, 2022:**
 - J. Anderson motioned to approve minutes from the January 11 Regular Meeting as distributed, and E. Patsiopolous seconded. The LSC voted to approve. 9-0.

 - The Participatory Budget initiative related to Solomon playground improvements was highlighted and residents are encouraged to vote.
 - The LSC discussed current mask-wearing policies as they relate to the recently lifted mandate.
 - The FOSSPTO is actively raising funds through restaurant give-backs. A Walk Jog Roll-a-thon is planned for 2022.
 - C. Gamble highlighted a new photography program organized by Mrs. Stirling and the upper grade team focusing on fashion and identity.


